### **Board Meeting July 17, 2012**

Marilyn Porter, president, called the meeting to order at 5:45 p.m. Other board members present were Sheryl Frank, vice president; Ray Gamble, secretary-treasurer; Ed Korte and Mike Gamble.

Also attending were Alexis Martin, on-site manager; Martha Ramcke, assistant manager; Mike Leach, maintenance superintendent; Dudley Leonard, cooperative attorney; and Melva Linville, property manager, and Suzanne Miles, human relations coordinator, with Linville Management Services, Inc.

The next meeting is August 21.

Minutes of the June 19 board meeting were approved.

Alexis discussed the office manager's report.

### **Open Session**

Thirteen members signed in for the open session at 6 p.m. They were Abby Dolman, Chelle Marler, Jean Hudgens, Joyce Layton, Helen McElfresh, Bonnie Corbett, Lindsay Torres, Michael Benz, Ida Rae Conners, Mike Riley, Janet Fairbanks, Jessie Phillips and Bea Parks.

Mike presented the maintenance report. From June 19 to July 17, 102 work orders were called in and 93 completed. Replaced were one refrigerator and one range.

There have been two move-ins and two move-outs.

Maintenance is halfway done with the air conditioning unit cleaning. Trimming the bushes has been completed.

Alexis gave the office updates. There have been 34 statements of charges due, three attorney referrals, 28 defaults, nine animal violations and one vehicle violation.

Seventeen units are for sale. Four of these are not paying carrying charges. Four applications are pending and two move-ins are scheduled.

Kenia Hernandez was recognized as the recipient of a \$200 referral bonus.

Marilyn opened the floor to member comments.

Bonnie Corbett won the door prize drawing of a \$25 gift card.

Marilyn thanked members for attending and the open session ended at 6:40 p.m.

#### **Closed Session**

Dudley discussed the pet permit. The board voted to add Akitas and Staffordshire Terriers to the list of banned breeds. "Pit bull" will be defined on the permit according to the language of the City of Independence municipal code.

The board approved a revision to the procedure for violators of pet rules. They will be given a first notice of 10 days to comply. If they have not complied, their account will be sent to the attorney for a final notice of 10 days to comply or their permit will be revoked and the pet must be removed.

Dudley reviewed the attorney status report.

The board agreed that a member can receive the Good Neighbor of the Month award only once in a year. The year begins with the annual meeting in September and ends with the next year's annual meeting.

The meeting was adjourned at 7:45 p.m.

# Board members sign ethics agreement

Serving on the board of directors is a responsibility and privilege.

The Independence Square board meets on the third Tuesday of every month except in September when the annual meeting is held on the third Wednesday. Meetings begin at 5:45 p.m.

In addition to regular monthly board meetings, the board may call special meetings throughout the year. Once elected, all board members are required to sign the Board Member Code of Ethics.

#### **Board Member Code of Ethics**

As a member of the board of directors, I will

- listen carefully to my teammates.
- respect the opinion of other board members.
- respect and support the majority decisions of the board.
- recognize that all authority is vested in the full board only when it meets in legal session.
- keep well-informed of developments relevant to issues that may come before the board.
- participate actively in board meetings and actions.
- bring to the attention of the board any issues that I
  believe will have an adverse effect on the cooperative
  or those we serve.
- attempt to interpret the needs of those we serve to the cooperative, and interpret the actions of the cooperative to those we serve.
- refer complaints to the proper level on the chain of command.
- recognize that my job is to ensure that the cooperative is well-managed, not to manage the cooperative.
- represent all members and not a particular court or interest group.
- consider myself a "trustee" of the cooperative and do my best to ensure that it is well maintained, financially secure, growing and always operating in the best interests of its members.
- always work to learn how to do my job better.
- declare conflicts of interest between my personal life and my position on the board, and abstain from voting when appropriate.

As a member of the board, I will not

- criticize other board members for their opinions, in or out of the board room.
- use the cooperative for my personal advantage or that of my friends or relatives.
- discuss the confidential proceedings of the board outside the board room.
- promise how I will vote on any issue before a meeting.
- interfere with the duties of the administrator or undermine his or her authority with staff members.
- act as a director outside of board meetings unless so authorized by the board. (Outside the board meetings, the board member is just like any other member and his or her status as a board member is restricted to times when the board meets as a group to hear reports, discuss problems, make reports and make decisions.)
- direct the cooperative staff. (Cooperative staff are to be directed by Management. When a board member

thinks something should be done, first it's brought out before the board. If the board decides to act, the board should vote on a motion notifying the Management Agent, and then let the Management Agent see that the motion is carried out.)

 reveal confidential information made available to the board to help make a business decision.
