### **City rules apply to** all dogs at large

The City of Independence requires that all dogs regardless of size be restrained when outdoors.

By City Code a dog is under restraint:

if it is in and cannot escape from a fully enclosed yard;

if the dog is on a leash of sufficient strength to confine it to the premises of the owners;

if the dog is fastened to a leash that is less than eight feet long and held by a person capable of controlling the dog.

"Invisible" fencing does not meet the definition of restraint.

The leash laws are designed to protect citizens and their dogs from harm. A loose dog may encounter a vicious dog, a dangerous wild animal or a car and be unable stop in time.

Unrestrained dogs also may strain relationships with neighbors by digging in yards, destroying decorations or flower beds, leaving waste behind or annoving the neighor's pets.

Finally, unrestrained dogs may hurt your pocketbook. Owners of animals deemed a public nuisance may be subject to a fine of up to \$500 for the first offense.

For owners who want to allow their dogs to run free, the City of Independence provides public spaces for responsible citizens to bring their dogs without violating the law: offleash zones in parks.

The Independence Leash-Free Zones are fenced, public areas where vaccinated dogs can legally run and play with other dogs under the supervision of their owners.

### **Put a Freeze** on Winter Fires

Home fires are a greater risk in the winter when people cook holiday meals, display decorations and use heat sources unsafely, according to the U.S. Fire Administration.

Statistics compiled by the National Fire Incident Reporting System reveal that cooking is the leading cause of all winter home fires and 5 to 8 p.m. is the most common time for winter home fires. More than 900 fire-related deaths occur annually and more than \$2 million in property is lost from these fires.

Residents are reminded not to use a range or an oven for additional home heating. Not only is it a safety hazard, it can also be a source of potentially toxic fumes.

In an effort to prevent injuries, fatalities and property damage, the USFA urges parents to educate their children about the nature of fire: fire can be fast, hot, dark and deadly.

Here are some tips.

Keep matches and lighters in a secured drawer or cabinet.

Encourage your children to tell you when they find matches and lighters.

Develop a home fire escape plan. Practice it with your children and designate a meeting place outside.

Supervise young children closely.

Teach children that fire is a tool, not a toy.

Show children how to stop, drop to the ground and roll if their clothes catch fire.

Show children how to crawl low on the floor, below the smoke, to get out of the house and stay out in the case of fire.

Teach children not to hide from fire fighters.

### **Tips to Secure Your Unit**

Signal 88 Security, the firm that patrols Independence Square Townhouses, offers these suggestions for protecting yourself and your property.

1. Obtain insurance to protect the value of your material possessions.

2. Consider using a bar to secure your sliding glass door.

3. Never prop your door open while you are gone, even when making short trips to visit a neighbor.

4. Pull the blinds shut so that would-be criminals cannot case your unit.

5. Be aware of people posing as door-to-door sellers. They may be checking to see who is not home.

6. Keep your car doors locked at all times.

7. If you see unusual activity in a vacant unit, report this to the office. After hours. call 816.868.4115.

8. Always confirm identification of maintenance technicians or outside service providers, such as the phone company.
