Should I be elected, I promise to share with you to the best of my ability the issues being voted on so you can let me know your wishes and concerns in regards to how you want me to vote.







The board of directors will recognize Sheryl at the annual meeting on September 17. As a recipient of the Good Neighbor award, Sheryl will receive a \$25 gift card.


