Observing Independence Square pet waste rules is easy now with the readily available bags. Not complying, however, can get expensive.

If pet owners don't comply, maintenance then is dispatched to clean up and members are charged \$25.

### City rules apply to all dogs

The City of Independence requires that all dogs regardless of size be restrained when outdoors.

By City Code a dog is under restraint:

if it is in and cannot escape from a fully enclosed yard;

if the dog is on a leash of sufficient strength to confine it to the premises of the owners;

if the dog is fastened to a leash that is less than eight feet long and held by a person capable of controlling the dog.

"Invisible" fencing does not meet the definition of restraint.

The leash laws are designed to protect citizens and their dogs from harm. A loose dog may encounter a vicious dog, a dangerous wild animal or a car and be unable stop in time.

Unrestrained dogs also may strain relationships with neighbors by digging in yards, destroying decorations or flower beds, leaving waste behind or annoying the neighor's pets.

Finally, unrestrained dogs may hurt your pocketbook. Owners of animals deemed a public nuisance may be subject to a fine of up to \$500 for the first offense.

For owners who want to allow their dogs to run free, the City of Independence provides public spaces for responsible citizens to bring their dogs without violating the law: offleash zones in parks.

The Independence Leash-Free Zones are fenced, public areas where vaccinated dogs can legally run and play with other dogs under the supervision of their owners.



# New Grounds Rule Approved

At the March meeting, the board approved an addition to the House and Grounds rules.

The new rules requires members who want to install a patio or deck to have a fenced backyard.

# Late fee policy in effect

The board voted to formalize the cooperative's policy on late fees at the March meeting.

Effective May 1, the official policy now states: "A late fee will be enforced on all carrying charges balances regardless of the amount."

The board also reviewed the Work Order Payment Arrangements policy and voted to raise the chargeable maximum amount to \$300 from \$200.

# Permit, rules protect pets, people

Pet owners must have a permit approved before pets move in.

Members who own a cat or a dog are required to complete a pet permit by January 31 of every year.

Permit applications must be accompanied by a certificate of vaccination and a one-time \$50 non-refundable fee for a pet. Any member who owns a pet without obtaining a permit and paying the fee will be required to remove the pet immediately.

When a prospective member submits an application, office personnel will take a photo of the pet as well as review the pet's certificate of vaccination.

A dog cannot weigh more than 65 pounds at maturity. Breeds not allowed are Akita, Doberman pinscher, boxer, chow, rottweiler, wolf or any other aggressive breeds or any dog mixed with these breeds.

Pit bulls are not allowed. A pit bull is defined as an American Pit Bull Terrier, American Staffordshire Terrier, Staffordshire Bull Terrier or any dog displaying the physical traits of any one or more of these breeds or any dog exhibiting those distinguishing characteristics which substantially conform to the standards established by the American Kennel Club or United Kennel Club for any of these breeds.

Dogs and cats must wear collars with shot tags and owner's identification tags attached at all times.

Pet owners are responsible for immediate clean-up of pet waste. If a complaint is issued, the member will be given 24 hours to clean up after the pet. If a maintenance employee cleans up after the pet, the member will be charged \$25 for this service.

Pet owners are responsible for all actions of their pets. Dog and cat bites will result in an immediate revocation of the member's pet permit and the member must remove the animal from the premises.

All pet owners are required to have pets spayed or neutered. Litters are not allowed.

Members must comply with the existing city ordinance prohibiting animals to run free or at large.

When a dog or cat is out of the member's unit or fenced yard, the pet must be on a leash or chain. The leash or chain must not be attached to a tree, shrub or permanent fixture. Dog houses or any type of pet houses are not allowed.

Visiting pets are not permitted.

All complaints against a member or the member's pet must be in writing. The complaint is kept in the office with the member's file.

Violations of this permit will result in a 10-day notice to comply. If the violation is not remedied, a second notice will be sent. If the violation is still not remedied, the pet permit will be revoked and the pet must be removed from the property.

### Doggie waste disposal bags available on site

- Rigorous enforcement of the rule requiring pet owners to clean up after their pets has begun this spring due to a significant increase in pet waste left on the grounds.
- Members are asked to report to the office pet owners who are observed to be breaking this rule.
- Pet waste clean-up reminder signs and stations with disposal bags have been posted on the property.
- We hope to encourage all members to clean up after their pets and keep the grounds neat and clean for everyone to enjoy.
- Whether rain, snow, sleet or hail, pet owners are expected to clean up after their pets in all weather. Those who fail to do so are sent a notice and given 24 hours to comply.
