concrete and/or asphalt patios will be allowed.

Brick, stone or patio blocks may be used because they are removable in case utility companies and/or maintenance need to make emergency repairs.

Pools/Slip-N-Slides: No swimming or wading pools shall be allowed except plastic wading pools no larger than eight (8) feet in diameter and no more than 12 inches in depth.

Slip-N-Slides are not allowed.

Water Usage: Water is provided for normal use.

Summer water usage is limited to filling a wading pool not more than twelve (12) inches deep and watering grass, shrubs and flowers.

Wading pools can be set up only in a fenced backyard and cannot be left in place long enough to kill the grass.

Running a sprinkler for children to play in is prohibited. If water is allowed to run unattended or allowed to run into the street, the member will be charged \$10 for excessive usage.

Washing motor vehicles on cooperative property is prohibited.

Annual household hazardous waste disposal slated for **April 5**

If you need to dispose of paint, pesticides or disinfectants, you can do so free on April 5.

The City of Independence is sponsoring its annual Household Hazardous Waste collection from 9 a.m. to 1 p.m. on Saturday, April 5. The drop-off will be at the large parking lot bordered by Osage, Liberty, Walnut and Kansas streets, one block south of the Independence Square business district.

The drop-off service is free to residents with proof of residency -- a driver's license of a city utility bill.

Chemical-based household products like oven and toilet bowl cleaners and other unwanted, old or unusable household products labeled as flammable, toxic, corrosive or reactive are considered hazardous waste. If such

products are handled, stored or disposed of improperly, they can be serious health or safety threats.

Products accepted at the drop-off include batteries, paint and aerosol cans, varnish, stripper, thinner, turpentine, fluorescent light bulbs, herbicides, pesticides, sprays, rat poison, weed killers, all automotive fluids, outdated medicines and mercury thermometers.

To find out about a specific product, contact Water Pollution Control at 816.325.7711.

To transport to the site, make sure all lids are on tight. Take the hazardous waste to the drop-off in the original containers, if possible. If containers are leaking, wrap in plastic and pack in larger containers with absorbent material, such as cat litter.

The Independence Police Department will provide a certified ordnance officer to collect and dispose of old or unwanted ammunition, explosives, firearms and fireworks.

The drop-off site will not accept electronics, appliances, trash, yard waste, medical waste, tires, asbestos, radioactive waste, pressurized gas cylinders or commercial waste.

Grounds Rules Keep Property Looking Good

Our buildings and streets are looking great, thanks to the renovations.

Now it's time to concentrate on the grounds.

Decks: Must not be attached to the townhouse nor obstruct utility meters or wiring. Please help keep our community clutter-free and attractive. Here are some of the rules members have agreed to follow when they signed their occupancy agreements.

Planting: Planting that could cause structural problems or Patios: Are confined to backyards and must be sloped mowing problems will not be approved. away from the townhouse to allow drainage. No poured Continued on next page

Vines: Vines will not be allowed on the buildings.

Flower beds: Flower beds in front or back yards shall be planted next to the buildings. They shall not extend beyond the stoop approximately fifty-six (56) inches.

They will be sloped away from the building to allow for drainage. Raised flower beds are not allowed.

Any type of edging used must allow for drainage and may not be taller than six (6) inches.

Yard ornaments: Yard ornaments are to be confined to the flower bed.

Fenced back yards: The member is responsible for fenced back yards. They are to be mowed and kept free of clutter.

Grass should not be more than six (6) inches tall.

If you receive notice from Maintenance to mow your yard, you will have forty-eight (48) hours to do so. If not done in this time period, Maintenance will mow your yard and a \$25 fee will be charged.

Bicycle, tricycles, Big Wheels and toys: When not in use, bicycles, tricycles, Big Wheels and such must be kept inside your unit or in the back yard next to the building.

Toys are to be stored inside the unit when not in use.

Clothes drying: Clotheslines may be installed in the basement.

You may install a rotary clothes-drying post in back yards only. No other type of outdoor clothesline is authorized.

When not in use, the rotary post must be stored in the unit.

Decks and Patios: Approved installation/alteration permit is required before any work begins.

Members must understand that if emergency repairs by utility companies and/or maintenance are required, the members are responsible for any costs incurred in removing and/or replacing the deck.
