# Independence Square members enjoy affordable advantages

At the annual meeting, Melva Linville, property manager with Linville Management Services, Inc., distributed information about cooperative living at Independence Square.

If individual members were required to pay the water bill for their unit, it would cost every household about \$35 a month.

Every member pays an average of only \$11 a month for all grounds maintenance such as mowing and snow removal and an average of only \$5 per month for security patrols.

If individual members were required to pay their own trash, it would cost every household about \$7 a month.

An increase of \$10 in carrying charges generates only \$22,560 in additional income to the property each year.

Every month, the Board of Directors holds an open session of the board meeting to allow members the opportunity to find out more about the operations of the cooperative.

Members can ask questions or voice their concerns to the board and to management. The open session is held at 6 p.m. on the third Tuesday of the month.

# Anti-theft tips for **Vehicles**

Thefts from motor vehicles generally occur when criminals drive or walk through areas looking for vehicles that are unlocked or have objects left in view, according to the National Crime Prevention Council.

It only takes a few seconds for a thief to break into your vehicle.

By taking a few simple precautions, you can take away the criminal's opportunity to make you a victim of this crime.

#### Always lock your vehicle with the windows rolled up.

The harder it is for a thief to get into your car, the more likely the their will move on to the next car.

Almost half of the thefts from inside motor vehicles involve a vehicle that was left unlocked.

#### Don't leave anything of value inside the vehicle in plain sight.

This includes cell phones, radios, briefcases, purses, packages, compact disks and other valuables.

They should not be left in your car period. But if they are, they shouldn't be in view.

#### Items that you can't take with you should be locked in the trunk.

If you can't take your valuables with you when you leave your car, at least lock them in the trunk where they are more difficult to find and steal.

#### Don't leave you vehicle unoccupied with the keys in it.

Don't do this even for a moment. Why make it that easy for a criminal to drive off with your car?

This is especially true at convenience stores or with children in the car.

#### If you have an anti-theft device for your vehicle . . . use it.

If you have a car alarm, set it. If you have a steering wheel "club," lock it in place correctly.

#### Make sure the license plates on your car are properly secured.

Make it difficult to remove your license plate by securing it tightly.

When your year sticker is in place, run a razor blade across it several times to make it more difficult to remove in one piece.

#### At night, park in well-lighted areas.

Not only will this deter thieves from stealing your car but you also will be safer when you return your vehicle.

#### Report all incidents as quickly as possible.

If you don't report a crime, the police won't know there is a problem.
